Regardless of the expiration date indicated on the RHB certificate/permit, a certificate or permit issued to a licensee of the healing arts (MD, DO, DPM, DC, PA) is current and valid ONLY if the individual's healing arts license is current and valid.

Title 17 of the California Code of Regulations [17 CCR 30403 (b)] requires that all licensees, including both physicians and physician assistants earn 10 approved CE credits in the two years immediately preceding the expiration date of their California Fluoroscopy Supervisor and Operator Permit. At least 4 of the 10 credits must be in radiation safety for the clinical uses of fluoroscopy.

California Fluoroscopy Supervisor and Operator Permit ...

In 2013, the Radiological Health Branch of California has adopted a new California fluoroscopy license examination. The new examination is administered by the ARRT. This new examination will be administered to California candidates who are required to take the examination to either satisfy (1) a radiologic technologist fluoroscopy permit or (2) a fluoroscopy supervisor and operator permit (generally for physicians and PAs.)

California Fluoroscopy License ARRT - (Best Guide)

In the state of California, any radiologic technologist or physician that uses fluoroscopy is required to submit a renewal for their permit. The Radiologic Health Branch of the California Department of Public Health is responsible for overseeing the renewal of these permits. The goal of this renewal is to ensure those using fluoroscopy are properly trained and informed to protect public safety.

California Fluoroscopy License Renewal: How to Maintain ...

Fluoroscopy permit holders need to earn 4 CE credits in radiation safety for the clinical uses of fluoroscopy in subjects related to the application of X-ray to the human body. Physician Assistants & Supervisor/Operator (California Licensed Physicians and Surgeons, Podiatrists, or Chiropractors) with fluoroscopy permit need 4 of the 10 credits in radiation safety for the clinical uses of fluoroscopy.

The Radiologic Health Branch (RHB) is within the Radiation Safety and Environmental Management Division of the Department of Public Health. The Branch enforces the laws and regulations addressing ionizing radiation, including radioactive material, designed to protect the public, radiation workers, and the environment.

In order to obtain your California RT license, you will need to pass the ARRT exam and submit the CRT license application [CDPH 8200] to the Radiologic Health Branch (RHB) of the California Department of Public Health. If you wish to apply for a fluoroscopy or mammography permit, you will need to download those forms from the RHB's website.

Fluoroscopy Supervisors and Operators are required 10 hours regarding the application of x-ray to the human body, 4 of which must be in radiation safety for the clinical use of Fluoroscopy. DOs are required 100 hours every two years, 40 of which must be AOA Category 1-A or 1-B Credit, and a maximum 60 of which may be AOA Category 2-B Credit.*
