Black Mental Health Care Program - Kentucky Mental Health Care

The Medicaid population in Kentucky is approximately 90% managed care with the remaining 10%, comprising mostly individuals in Long Term Care and Waiver programs. There are five Managed Care companies supporting Kentucky managed care: Aetna, Anthem, Passport, WellCare, and Humana CareSource. As

Medicare is a Federal program, identified as Title XVIII, basically serving persons sixty-five (65) years of age and older, and some disabled persons under that age. The Kentucky Medicaid Program serves eligible recipients of all ages.
