Other more general laws like the Health and Safety at Work Act 1974 may apply to manual handling, but MHOR is the only specific UK regulation.

## **What are the Manual Handling Operations Regulations 1992 ...**

The Manual Handling Operations Regulations 1992, have provided a general framework for managing safe manual handling activities at work. The regulations state: to avoid Manual Handling activities where it is reasonable and practicable to do so, and ,where it is not, to assess the risks and take appropriate steps to reduce it so far as reasonable practicable

## **Manual Handling Operation Regulations 1992**

The Manual Handling Operations Regulations (often abbreviated to MHOR) is a piece of Health & Safety legislation that affects both employers and employees. It passed in to law in 1992, and was amended in 2002.
