Factors include household size, monthly income, and if a member of your household is 60-years-old or older, or has a disability. The income requirements for food stamps in Pennsylvania also allow for the following deductions: A deduction of 20 percent from earned income. A standard deduction of \$164 or potentially more, depending on the size of your household. A

Gross income refers to all of your earned income (like wages and salaries) and all unearned income (like public benefits and social security) before any taxes or deductions are taken out. In order to qualify for food stamps, your gross income needs to be below the amount in the following table.

Step 1 □ Gross Income: The federal minimum wage is currently \$7.25 per hour. Full-time work at this level yields monthly earnings of \$1,256. Step 2 □ Net Income for Shelter Deduction: Begin with the gross monthly earnings of \$1,256. Subtract the standard deduction for a three-person household (\$167), the earnings deduction (20 percent times \$1,256, or

Net Income Calculation Example for a 4-person household;
Subtract 20% earned income deduction... \$2,050 gross
income \$1,500 earned income x 20% = \$300. \$2,050 - \$300
= \$1,750: Subtract standard deduction... \$1,750 - \$181
standard deduction for a 4-person household = \$1,569:
Subtract dependent care deduction... \$1,569 - \$362
dependent care = \$1,207

The SNAP income guidelines in PA require households to have a low income and limited amount of financial resources. Generally, a household's income must be at or below 130 percent of the poverty level. By definition, income includes anything that a household member earns as payment for
